**Resolution No. 2005-9**

A RESOLUTION TO MAKE AND CHANGE ROAD/STREET NAMES TO IMPLEMENT SNYDER COUNTY ENHANCED 911 PUBLIC SAFETY SYSTEM

*Whereas*, Snyder County is implementing the Enhanced 911 Public Safety System which, when completed, will provide for improved emergency response that benefits the health, safety and welfare of all citizens of this municipality; and

*Whereas*, in order to implement this system, it is necessary to develop an addressing system that is comprehensive, expandable and easily understood; and

*Whereas*, Snyder County has developed an addressing plan for the entire County which is based on a linear system that will provide a unique physical location address; and

*Whereas*, in order to implement this system, it is required that certain public roads or streets within the municipality be renamed to eliminate duplicate road names within the delineated 911 zones and to name and mark certain private roadways within the municipality.

*NOW, THEREFORE, BE IT RESOLVED AND ENACTED* by the Board of Supervisors of the Township of Monroe it is hereby *Resolved* as follows;

**Section 1.** That the names of the existing Monroe Township public roads, and state public roads shown on the attached list are valid and official road names in the municipality and that hereafter these streets or roads shall be identified and officially recognized by the names indicated herein.

**Section 2.** That the private roadways identified on the attached list are valid and official road names in the municipality and shall be hereafter known by the names indicated herein.

**Section 3.** That a certified copy of this resolution shall be filed on record with the Clerk of Courts of Snyder County, Snyder County 911, and the appropriate Office of the Pennsylvania Department of Transportation for the purposes of securing official documentation of the names hereby designated.

**Section 4.** That this Resolution shall be effective immediately and shall remain in effect until modified or repealed by further Resolution of the governing body.

**Section 5.** That all [REDACTED] Resolutions and parts of [REDACTED] Resolutions inconsistent herewith are hereby revoked.
